 <h4>NOTICE</h4> <p>Be aware of the vulnerabilities that can lead to radicalisation and notice the signs of changing behaviour and attitudes which can become a cause for concern.</p>	 <h4>CHECK</h4> <p>Check your concerns. Seek out a second opinion from your manager and/or designated safeguarding lead, in line with your safeguarding policy.</p>	 <h4>SHARE</h4> <p>If decided by senior staff, share your concerns with the student and those who can help (e.g. Channel). Any response to the young person must be proportionate to the risk.</p>
